

INFORMATION RENDERED FOR THE PROCESSING OF PERSONAL DATA

Pursuant to and for the purposes of articles 13 and 14 of EU Regulation 2016/679 regarding the protection of personal data

Pursuant to the effects of articles 13, paragraphs 1, and 14 of EU Regulation 2016/679 on the protection of personal data, the company Azienda Agricola Villa Crine di Venturini Giovanni Battista - with registered office in San Pietro Incariano – (Verona - IT), henceforth also the "Company", in person of the legal representative pro tempore, hereby provides you with the information relating to the processing of your "Personal Data", voluntarily provided by you, for the activation of the personalized services requested.

The company, to offer you personalized services, needs to process some of your personal data, as better specified in the sections relating to the services themselves, adopting the appropriate measures to guarantee their security and confidentiality, in compliance with the aforementioned legislation.

We will therefore ask you to express your consent for the processing of data strictly necessary for the operations and services requested by you, at the time of your accession.

1. Collection of information

- 1.1. This information concerns the data collected through the data entry forms present in correspondence with the services:
 - a. information request
- 1.2. The personal data you provide to our Company will be recorded and stored on protected electronic media. The data will be processed exclusively with methods and procedures strictly necessary to provide you with the requested services.

2. Purposes and methods of data processing

- 2.1. The data collected in the cases referred to in paragraphs a, b, c, d of point 1.1 are processed exclusively for the following purposes:
 - a. Collection, storage and processing for the purpose of establishing and operating, administrative and accounting management of the contractual relationship connected with the provision of the services offered on our site;

3. Nature of the provision of data

- 3.1. The provision of personal data is optional. Failure to provide, even partial, the data will make it impossible for Azienda Agricola Villa Crine di Venturini Giovanni Battista to proceed with the full provision of the services requested by you at the time of your accession.

4. Disclosure of Personal Data

- 4.1. Without prejudice to communications made in fulfillment of legal obligations, all data collected will be processed by:
 - a. internal and external data processors;
- 4.2. In any case, personal data will not be disclosed except in the cases provided for by law.

5. Duration of treatment

- 5.1. All data will be kept exclusively for the performance of the service regarding the purposes referred to in chap. 2.

6. Owner and manager of the treatment

6.1. We inform you that the Data Controller is the company Azienda Agricola Villa Crine di Venturini Giovanni Battista with registered office in San Pietro Incariano – (Verona - IT), contactable through the mailbox info@villacrine.it

7. Profiling

7.1. Your personal data will not be subject to treatment techniques consisting of the profiling of the natural person, in particular they will not be analyzed to predict their preferences, behaviors and personal positions.

Exceptions and limitations are reported in Articles 22 and 23 of the regulation.

8. (Right of access to personal data and other rights)

8.1. We also inform you that in relation to the aforementioned treatments, you can exercise the rights referred to in Articles 15, 16, 17, 18, 19, 20, 21, 22 of the regulation.

- a. Art. 15 - (Right of access of the interested party)
- b. Art. 16 - (Right to rectification)
- c. Art. 17 - (Right to erasure "right to be forgotten")
- d. Art. 18 - (Right to limitation of treatment)
- e. Art. 19 - (Right of notification in case of rectification, cancellation or limitation of treatment)
- f. Art. 20 - (Right to data portability)
- g. Art. 21 - (Right to object)
- h. f. Art. 22 - (Right not to be subjected to profiling or automated processing)

9. Cookies

9.1. The website uses technologies such as cookies or similar technologies for the purpose of having an easier navigation and greater ease of use of the site by the user. The information allows the site to "recognize" users when they return or browse by going from one page to another and to "remember" their preferences: language, password, favorite content, etc. The cookies used are:

- a. session information that is removed from the user's computer when the browser is closed;
- b. persistent, information that is located on the hard drive of the user's computer and that is not deleted unless the user himself intervenes.

9.2. The site may also contain links to other websites that have their own privacy policy. These privacy policies may be different from that adopted by the Company, which therefore is not responsible for third-party sites.

9.3. The consent to the use of cookies is expressed by the interested party through the individual setting that he has freely chosen for the browser used for navigation. However, the user remains free to communicate to the Data Controller at any time his / her will regarding the data managed through the cookies that the browser has accepted.
